#### FERS Retirement Planning Tool Update\* By Randy Bradley, HQ AFMC/FMC

As I prepare for my retirement effective 31 July 2020, I wanted to distribute the "Production" version of the FERS Retirement Planning Tool to everyone who has either received a previous version and/or a demonstration of the tool. This is the version that contains all of the latest factors and bells and whistles from the recommendations of everyone who beta tested it. The FERS Retirement Tool was carefully crafted using many of the same principles used by a Certified Financial Planner (CFP) and the tax formulas contained in the tool were validated by a government employed Certified Public Accountant (CPA). The tool accounts for the following income sources:

- FERS Basic Retirement Benefit (Pension)

- FERS Annuity Supplement (if applicable)
- Social Security Benefits
- TSP Withdrawals (Traditional and Roth)
- IRA/401(k) Withdrawals (Traditional and Roth)
- Other Pension Benefits (e.g. Air Force Reserves, former employer, spouse's pension)
- Other Income (e.g. Rental income)
- Sale of Accrued Annual Leave

What you will need to get started:

- Current LES
- Estimated High-3 (page 6 of your Total Compensation Statement in the GRB Platform) https://w45.afpc.randolph.af.mil/AFPCSecureNet40/CheckPortal.aspx
- Current TSP balances (Traditional and Roth)
- Current IRA/401(k) balances (Traditional and Roth)
- Annual Social Security Statement
- How to get a Social Security Statement https://faq.ssa.gov/en-us/Topic/article/KA-01741 Other employer pension statement (e.g. Air Force Reserves Retiree Account Statement)

If you copy and paste your inputs from a previous version into the updated tool, which can be found on the ASMC Aviation Web page https://www.asmc-aviation.org/professional-development, please **use the Paste Values option**. Also note that you must enable the Printer Friendly LES in myPay if you enter your latest LES inputs into the tool directly from the myPay website. Many, MANY THANKS once again to George Diehl, Kevin Locker, and Summer Bartshe for their expertise and assistance in the development of the tool, and the support we received from Ms. Teresa Frank and the HQ AFMC/FM Front Office to help make it all happen!

Unfortunately we weren't able to get the tool distributed to the audience I had anticipated it would be made available to. You can scroll down to the 18 Jun 20 email from USAF AF-A1 (USA) for the specifics but the long story short is that the Air Force's current digital transformation and streamlining efforts prevent the tool from being distributed for Air Force wide use.

I've worked with some of you over the years and it's been a real pleasure! I feel blessed that I could give the Air Force over 39 years of service (35 years as a civilian here at W-P and 4 years of Active Duty in the AF). That time also includes 17 years in the Ohio Air National Guard from which I retired in 1999. My blood truly runs blue!

### Rent or Buy Router/Modem

When purchasing internet service, a decision which many users should consider is whether or not they should rent the router and modem from their selected internet service provider (ISP). Unfortunately, this decision can be a little tricky for some. The balance between cost, level of control, and autonomy of network maintenance are major factors. Below are some pros and cons which users may want to be considered when deciding whether to buy hardware or rent it from the ISP.

#### **Renting Router and Modem:**

Renting is by far the simplest option and require the least amount of technical knowledge. The hardware will be guaranteed to be compatible with the ISP. More accessible ISP technical support as they will have specific technical details and capabilities for supporting the hardware they provided. For users who have no interest in managing their settings and hardware, renting is the ideal options. However, renting is likely the more expensive option over time. Within nine to twelve months, renting begins costing more than purchasing similar or better hardware. Many ISPs now save the settings (e.g., WIFI name and password) on the rented hardware to the user's profile. Depending on privacy preferences, this may be an issue for some users. Security features and firmware updates are limited to what the ISP provides and may be infrequent.

#### **Buying Router and Modem:**

Buying provides users with the most control and requires some degree of technical knowledge depending on the desired features of the hardware. Purchased hardware can have more features such as guest networks, advanced network controls, firewalls, etc. which may not be available on ISP hardware. The extra features give users more control over their network and more privacy. In most cases, users can take their hardware and switch between ISPs without the need to return the old ISP hardware and waiting to receive the new ISP hardware. However, buying does come with need for a little more effort to get everything up and running. Additionally, users would want to verify that the hardware is compatible with the ISP although this would only be an issue with very small or local ISPs. Finally, some ISPs may blame the hardware for any service issues.

#### **Guest Networks**

Most standard networks enable connected devices to communicate with each other and the internet. Many routers today now come with the additional capability to create a guest network. Guest networks are a separate network your router creates where none of the connected devices can see or talk to each other but can only use the internet. The usage of a guest network can add an extra layer of security to your home network. In most cases, if you have an infected device on your guest network, the rest of your devices are isolated and safe. Additionally, devices connected to your guest network are unable to access the router's settings. In general, users should implement a guest network if possible. If a device does not require access to other connected devices (e.g., network printer or hard drive), then they should be using the guest network. Smart/Internet of Things (IoT) devices, children, and guests should, at the most, only be allowed to connect to the guest network. When setting up a guest network, use a WIFI name and password that is different from your normal WIFI name and password.

#### **PowerPoint Media Presentation Shortcuts**

will increase and decrease the volume respectively. Alt+U will mute the sound.

Sometimes it can be difficult to run media while you are in the Presentation Mode of PowerPoint. Many times this is simply due to not being able to find your cursor since your computer is often connected to the projector as well as a monitor. Here are a couple of tips on how to run media without a mouse that may help you out. If you are using hyperlinks in your presentation, you can simply press Tab to cycle forward through the hyperlinks on the slide and Shift +Tab to cycle backward through them. Pressing Enter while a hyperlink, the link will be opened. When you are playing audio/video files in your presentation, there are a few shortcuts that can help you react quickly if there is an issue while the media is playing. Ctrl+Space or Alt+P will toggle between play and pause. Alt+ $\uparrow$  and Alt+  $\downarrow$
