The Digital Optimization of the AFMC International Affairs Portfolio Report

"There are known knowns. These are things we know we know. There are known unknowns. That is to say, there are things that we know we don't know. But there are also unknown unknowns. There are things we don't know we don't know." -Donald Rumsfeld

If you work in Foreign Military Sales (FMS) financial management, this quote rings true. The volume of nuances associated with FMS financial execution and reconciliation as well as more systems and responsibilities to accomplish required activities after defense materiel and services have been delivered to the foreign partner contribute heavily to the challenges of FMS financial management. It is common for a financial manager to have access to 10-15 systems in order to accomplish our jobs. Many of these systems and databases do not interface with one another and financial managers spend a great deal of time reconciling data between them. FMS activities utilize 3 systems to manage funds, adding yet another layer of complexity to reconciliation efforts. Further complicating the ability to balance funds execution and reconciliation on a daily basis is the pure volume of lines, or budgets, financial managers are responsible for. Currently AFMC executes 27,325 lines on 2,923 active cases.

Over the past two years, the Air Force Security Assistance and Cooperation (AFSAC) Directorate Financial Management Division, in collaboration with Case Management, led the digital optimization of the \$255B FMS portfolio and established the FMS Scorecard report in the Program Management Resource Tool Enterprise Analytics (PMRT-EA) platform in order to promote proper oversight of funds execution and reconciliation. Digital optimization utilizes digital technologies, such as data analytics, and improves existing tools and processes. AFSAC leveraged an existing FMS reporting system, AFSAC Online (AOL), and developed new interfaces within PMRT-EA, combining data from FMS specific systems, DFAS, and the Comprehensive Cost and Requirements (CCaR) system. This new report provides Program Executive Office / Directorate and program office portfolio values, tracks period of performance, and displays execution and reconciliation status. Additionally, the Scorecard provides leaders and analysts the capability to proactively manage funds, identify adverse financial conditions, and ensure timely customer billing of 2.9k FMS cases across the AFMC enterprise.

Why is this a game-changer? Prior to the FMS Scorecard, organizations resorted to manual methods to extract data from each of the unique FMS systems at varying levels to combine into labor intensive reports. Due to the manual processes, financial managers were challenged with identifying system discrepancies, over-executed lines, or stagnant expired lines. Now with a click of a button, anyone managing FMS can obtain tailored reports with up-to-date portfolio values, while also reviewing the FMS Scorecard to identify areas of concern and take immediate action. The report closes the gap on the known unknowns and unknown unknowns by provoking inquiries and action when data is highlighted red. Additionally, analytic features have been incorporated into the report to proactively manage FMS case lines to assist in determining additional funding requirements or period of performance extensions are necessary, reducing the chances of work stoppage or delay in requirements execution.

AFSAC was able to identify the root cause of some unknown unknowns associated with various Security Cooperation fund types. Standardization is a critical element of data analytics. The FMS Scorecard reporting capabilities rely on data fields being used properly (naming conventions and proper elements) and fields not being left blank (if it is supposed to have an element). Whether you are building a budget in CCaR or preparing a funding document in any system, data fields matter. Lack of standardization will inhibit the advancement of reporting capabilities and in essence, the fidelity of financial execution and reconciliation. As the FM field digitally optimizes with various data analytic platforms, please take a moment to consider how your current actions contribute to the advancement of financial reporting.

Malvertising

A newer way malicious users can trick you into visiting their sites is called Malvertising. This is a practice where the malicious user's setup a site then buys advertisements, which are used to trick us into clicking based on them of their site. Some sites may be designed to steal credentials while pretending to be a financial site or they may be used to distribute malware while pretending to be the site for a popular application or tool. The advertisements they purchase are the same advertisements you will see at the top of a list of search results. Since their advertisement was legitimately bought, it will appear in your search results based on your browsing data that is regularly collected and sold (i.e., ads for new or discounted tires start showing up after you searched for the "best winter tires in 2022"). While these ads will eventually be removed when discovered, they may not be detected as quickly since they are being distributed through legitimate means. The safest practice you can have to avoid this, and other attacks, is to never click on ads or links from a non-trusted or unsolicited source. This article by the FBI provides some additional information on Malvertising.

Sending Spam Calls to Voicemail

Spam calls, or robocalls, are irritating, dangerous, and persistent. One of the best ways to stay safe with respect to these calls is to simply ignore them. No matter your reasons, simply answering one of these calls can cause your number to be flagged as active resulting in more calls. Setting your phone to ignore or block these calls may be useful for some people This article provides some basic instructions on how to do this with Android and iPhone devices.

Managing the Windows Taskbar

The Windows Taskbar can be customized in a few different ways. Toolbars, Search, Cortana, and News and Interests are some of the options. Each of the items described here can be accessed from the Taskbar popup options. Right-clicking on the Hidden Icons, the "^" button in the lower-right corner of the screen, is the easiest way to access the Taskbar options. Both toolbars can be useful depending on the way you use your computer.

First, the Taskbar has some toolbars that can be enabled. The "Toolbars" option holds two specific toolbars by default that can be valuable for some users. When you select a tool bar, it is added to the Taskbar to the left of the System Tray where the clock and WIFI icons can be found.

Address – This is a box where you can input a web address, your default internet browser will open and navigate to the website, or a file path, Windows Explorer will open the specified folder. Enabling this toolbar can provide quick access to specific links or file addresses.

Desktop – This will put a dropdown list of all the files and folders on your desktop on the Taskbar. Enabling this toolbar can supply quick access to your primary file locations (e.g., user files, OneDrive, and This PC) as well as the content on your Desktop.

Second, the News and Interests feature will display a small newspaper icon in the lower-right corner of the screen on the Taskbar. This feature is intended to enable users to quickly access news, weather, traffic, etc. While this feature may be convenient for some, it could be troublesome when your computer is running slow or a distraction if the user does not want the feature enabled. News and Interests options include the ability to toggle the icon and text, turn the feature off, or disable its activation when hovering to prevent accidental opening. More details can be found in this article.

Third, the Search feature provides the options to show a search box or search icon to the right of the Start Menu button in the lower-left corner of the screen.

Finally, the Cortana, Task View, People, Windows Ink, and touch keyboard buttons can be added to the taskbar. Like the toolbars, the usefulness of these buttons is dependent on the way you user your computer. The detailed options for the Taskbar can be accessed when you select the "Taskbar settings" choice.
