November Member Meeting

On 16 Nov 2023, Mr Jamie Mason, SAF/FMFS (AFFSO), presented SAF/FMF Air Force Financial System office (AFFSO) Projects and Updates. Mr Mason is the senior technical advisor, and directly oversees eleven Air Force financial system operations apps or programs, which are used daily across the Air and Space force to support the missions of our airmen. In addition, he oversees the Robotics Process Automation (RPA) team, which develops automations to streamline manual FM activities and provides training to FM personnel, so they can create their own automations. Below are the eleven programs they manage, which range from programs that have been around for decades to new systems they are developing.

They just launched in September the Leave Web mobile app. This brings a whole new level of access and challenges to our systems. You can see that since we launched two months ago, we already have over 27,000 downloads, which is great. The mobile app has had over 1,500 leave created and over 6,500 actions (submissions/approvals). Leave Web mobile app doesn't provide all the functionality of the main app, but it does provide functionality for users to be able to go out there and create their leave. Mr Mason did mention of the challenges they faced was the scams that appeared within the first two weeks of launch. He reminded folks to remember your cyber-security and operational security. The Leave web mobile app must be download from the approved Google Play Store and Apple App stores <u>do not go to a website and try to download it.</u>

Mr Mason was asked the question about Okta and how it works. Okta is the third party tool that the Air Force has approved for logging in for authentication. So when you do CAC login, that's the tool that is verifying you are who you say you are, and getting access to the data and the systems that they need. That's taking the information from your CAC using two factor authentication hitting the the official Air Force identity. However, mobile app for example, most folks don't have a CAC reader with their phone or their mobile device, so they have Okta offers other two factor authentication methods besides CAC.

Mr Mason then spoke about the Comptroller Services Portal (CSP). It was an elevated SharePoint site that allowed customers to be able to submit inquiries to the Comptroller offices. Eventually they couldn't maintain that on a SharePoint site any longer, so they had to develop and turn that into a a full fledged system. So in August, they deployed the CSP system. When they deployed CSP of course there were bugs. A lot of them had to do with access and authentication which are common. Their team worked really hard and resolved most in less than 30 days. They are continuing to work issues as they take CSP Air Force wide and deploy additional functionality like AI Chat BOT. Mr Mason stated they need to make sure everyone can use the systems the way that they're supposed to be used. Everyone can submit their own queries and get the support they need.



The next topic Mr Mason spoke on was ICAM (Identity, Credentials, and Access Management). ICAM is a cybersecurity domain that allows you to securely access resources across existing systems and emerging platforms. ICAM, ensures that the right person with the right privileges can access the right information at the right time. Mr Mason stated the issues they have seen with Leave Web and CSP are bigger issues that will impact all the systems across FM and and even beyond FM as we start to implement ICAM across the Air Force. So they're leveraging these two systems and identifying and documenting these lessons learned and passing them along so that other systems won't have to experience these.

The next initiative they are working on is to develop a PCS Automation system. They successfully completed a pilot September 2023 that demonstrated that they could do active duty CONUS to CONUS.

Mr Mason then gave a status on what is going on with CRIS. They have identified Advana FASTR as potential CRIS replacement. Advana is the DoD warehouse for all data and analytics to support auditable data. The AFFSO is working with FASTR team to perform analysis on transition. Mr Mason stated, CRIS will not sunset unless there is a 100% viable solution that can take its place, meaning FASTR or any other solution will have to be able. Volunteers are needed to participate in user groups to provide feedback and perform testing. If interested contact Mr James Mason, james.mason.24@us.af.mil.

The last program Mr Mason discussed was robotics (BOT) automations. To date they have developed 59 automations. These automations automate repetitive manual processes and each year these automations save thousands of man hours. The automations they have developed so far are attended automations, where someone has to sit at the computer and mainly push the button to start the automation. Mr Mason said they are working to get licensed to run unattended automations that will greatly expand Enterprise level solutions and time savings.

Mr Mason encouraged attendees, if you have any ideas or things you'd like to see added to these systems, please submit a request through the program office, help desk, or Functional Review board representative. He also said to check their quarterly newsletter for updates on their programs.

Augsburg Memorial Scholarship

History

The Augsburg Memorial Scholarship was named for Fred and Susan Augsburg by the members of the ASMC Aviation Chapter as a lasting beneficial memorial to their friends. The couple was vibrant, outgoing, fun-loving individuals, and true professionals in their jobs. Tragically, in February 1987, they were killed in a traffic accident in Lexington, Kentucky. A drunk driver crossed the centerline and struck Fred & Susan while they were jogging. Both died from their injuries. About the Scholarship

The Augsburg Scholarship is funded by both CFC and individual donations and managed by the American Society of Military Comptrollers, Aviation Chapter, Wright-Patterson AFB, OH. 100% of contributions go towards the scholarships, with no administrative costs.

The Augsburg Scholarship Fund promotes education and training through scholarships for graduating high school seniors and continuing college students who live in or attend school in Southwest Ohio, and are majoring in accounting, financial management and related courses of study.

The two High School scholarships awarded at the local chapter are \$1,000 per year for a total of \$4,000 to deserving high school seniors graduating each year, who plan to pursue a college degree in the specified areas of study. The two College Continuing Education scholarships are awarded in the amount of \$1,000 each to deserving continuing college students pursuing a degree in the specified areas of study.

Outlook Meeting Response Options

When setting up a meeting invitation in Outlook, some settings are available to change how a recipient can respond. Three Response Options are available and are enabled by default. The meeting organizer can Request Responses, where Outlook will ask the recipient if they would like to send their Accept, Tentative, or Decline responses. Additionally, the organizer can Allow New Time Proposals, where the recipient may send a response with a new proposed time. Finally, the organizer may choose to Allow Forwarding or not.

These options can be found in the Meeting tab of the Ribbon. Then go to the Response Options dropdown. The three options can be toggled within this dropdown.

"Direct Replies To" in Outlook

Sometimes when we send an email out to a large group or on behalf of someone else, we need to have replies to go directly to other people. In Outlook you can set an email to put one or more people's email address(es) in addition to, or in place of, your email in the To box when someone replies to your email. When you have the email that you are about to send open. Go to the "Options" tab in the ribbon and click on the "Direct Replies To" icon. This will bring up the "Properties" window. In the "Delivery Options" section of the "Properties" window there is a "Select Names" button you can use to assign who replies are sent to.

Office AutoCorrect Settings

The AutoCorrect feature in Office can be very helpful when writing content in Excel, OneNote, Outlook, PowerPoint, and Word. This feature makes automatic corrections to your content as you type. However, there can be instances where AutoCorrect's behavior can work against you. Examples of this can include using words that are not in its dictionary or using specific number notations. Some of the AutoCorrect settings include disabling when it adds superscript formatting to ordinals (e.g., 1st to 1st) or automatically adding hyperlink formatting to file and web addresses. To access all the settings, open an Office desktop app. Click File, and select Options. In the Word Options window, click on the Proofing section. The "When correcting spelling in Microsoft Office programs" has a few settings including custom dictionaries. Above that section, there is an AutoCorrect Options button. Clicking this button will provide access to all of AutoCorrect's settings.

Office's Tell Me Feature

The "Tell me what you want to do..." feature was introduced in Office 2016. Office has always had more buttons, options, and features than we can keep track of. The Tell Me feature enables you to search for the specific option you need versus clicking randomly throughout the ribbon. In Excel, Outlook, PowerPoint, and Word you will notice a small lightbulb icon at the top of your ribbon regardless of which tab you have selected. Click in the area that says, "Tell me what you want to do..." and begin searching for your desired option. Depending on the interface you are using, such as the web apps vs. desktop apps, there may just be one big search bar at the top of the ribbon. In this case, the search bar will search for buttons (i.e., Actions) matching the criteria you enter as well as filenames and file contents. For example, searching "Slide" in PowerPoint will list options such as New Slide, Slide Layout, Reset Slide, etc. as well as files with "slide" in the name or content. Pressing Alt+Q will take you directly to the Tell Me search box.

Outlook Keyboard Shortcuts

Alt+W or Ctrl+F will open the Forward message composition for the selected message Alt+R or Ctrl+R will open the Reply message composition for the selected message Alt+L or Ctrl+Shift+R will open the Reply All message composition for the selected message Ctrl+E will put the cursor in the Search Current Mailbox search bar
