# **MONTHLY MEMBER MEETING**

On 4 March 2025, Mr Todd Baker presented, Understanding Technology Hype. Mr Baker, Senior Financial Operations and Business Transformation Advisor for SAF/FMF. Mr Baker represents FM interests and requirements for new capabilities, interfaces, program sustainment and user experience to improve organizational processes with non FM stakeholders. Mr Baker is responsible for understanding new technologies and being able to advise our Air Force leadership on sort of when and where these technologies might fit into our current environment.

Mr Baker stated that artificial intelligence (AI) is the next wave of technology. He then discussed the technology hype cycle and its relevance to DoD technology adoption, particularly within financial management. Mr Baker used Gartner's Hype Cycle model to illustrate how new technologies progress through stages of inflated expectations, disillusionment, enlightenment, and finally, productivity. He highlighted the tendency for the DoD to lag behind industry in adopting new technologies due to the complexity of implementation within large government systems.

Using examples from past and last year's PDIs, Mr Baker demonstrated how "hype" drives focus on specific technologies, like data analytics and, more recently, AI. They emphasize that not all hyped technologies are equally mature or suitable for immediate implementation. Examples of emerging technologies in various stages of the hype cycle are provided, including electric aircraft, wireless EV charging, and hydrogen vehicles, illustrating how expectations and timelines can vary.

Focusing on AI in finance, Mr Baker explained concepts like causal AI (understanding cause and effect), self-integrating applications, generative AI (like ChatGPT), and Retrieval Augmented Generation (RAG). While generative AI is currently experiencing peak hype, it lacks the explainability and causal reasoning crucial for financial applications. Causal AI and self-integrating applications hold significant promise but are still in early stages. RAG, which allows AI interaction with user-uploaded documents, is closer to practical application. The overall message is to be aware of the hype cycle when considering new technologies and to prioritize mature, proven solutions for complex government projects.

Mr Baker stated, while initial enthusiasm suggested AI could revolutionize areas like accounting and fund control through explainable AI, current applications haven't reached that level. The concept of the "citizen data scientist," empowering individuals with data analysis tools, also hasn't scaled as predicted, with centralized data analysis remaining more effective. However, embedded analytics, like AI assistants within existing software (e.g., Microsoft Copilot), are showing practical value. Predictive analytics for cost modeling, while initially hyped for financial markets, is now finding more realistic applications within government cost projections. Mr Baker then emphasized the importance of adopting mature technologies in complex government projects. He also recommended resources like Gartner's Hype Cycle and exploring tools like ChatGPT to understand AI's evolving role. In addition, there are YouTube videos and other tools if interested in understanding more.

Mr Baker acknowledged there are limitations of current AI capabilities, but there is potential of emerging applications as they mature.

Mr Baker was presented with a certificate of appreciation from the Aviation chapter and donation in his name to fthe Air Force Assistance Fund.

# SDFM Audit Task Force Lays Groundwork for Long-Term Audit Sustainability in Defense Financial Management (ALEXANDRIA, Va., March 4, 2025 / PRNewswire/)

The Society of Defense Financial Management (SDFM) is taking a pivotal role in ensuring the long-term sustainability of clean audit opinions across the Department of Defense (DoD). SDFM CEO Rich Brady echoed this sentiment, emphasizing the value of audit integrity in both the public and private sectors. "A clean audit opinion isn't the finish line; it's the foundation for better decision-making, resource allocation, and operational efficiency. In the private sector, companies leverage audit findings to drive business improvements—our defense community must do the same. The SDFM Audit Task Force is committed to ensuring that once the DoD achieves a clean audit opinion, it has the tools and strategies in place to sustain it."

Chaired by Mr. David Clifton, a retired DoD senior executive with 40+ years of government service, the SDFM Audit Task Force is composed of senior financial management professionals, auditors, and policy experts dedicated to advancing financial stewardship in the defense sector. By developing innovative solutions and fostering cross-sector collaboration, the Task Force is helping to shape a culture of continuous improvement that aligns with the DoD's commitment to transparency and efficiency.

#### **Schedule Teams Chat Messages**

In addition to instant chat messages, Teams enables users to schedule a chat message. Scheduling a chat message works same way as using the delayed send option for Outlook emails. When composing a chat message you would like to auto send at a later point in time, right-click on the Send button. The options for a date and time will appear, select the time and click the Continue button. Once the delivery time has been selected and the message is ready, hit send like normal. The message will appear in the chat with the scheduled time. Scheduled messages can be edited and deleted like any other messages. This feature is only available for chat message, not channel posts. Manage Calendar Notifications in Teams

The Teams Activity Feed has the ability to show meeting invitations and modifications in addition to chat and group notifications. While this enables users to see more in their Activity Feed, this additional category of notifications may make the feed too noisy and potentially redundant to the meeting invitations received in Outlook. The ability to toggle these notifications can be found in the Teams Settings in the Notifications and Activity section. Scroll down to the Calendar section, where a toggle for "New invites, updates and cancellations sent to me" can be toggled on and off. Another toggle is available for "When people forward meetings I've organized."

#### Microsoft To Do

The Microsoft To Do app is a task manager app that is intended to help users stay organized. To Do enables users to create, manage, and share tasks and lists as well as set due dates and reminders. As part of Office 365, To Do can is integrated with the Outlook and Planner apps. In Outlook, the To Do app will appear in the left-hand app launcher in Outlook. If it is not visible, click on More Apps to locate it. Once open, To Do will organize tasks by Important, Planned, Assigned to me, Flagged email, and Tasks.

Users can also access To Do by going to their Office 365 homepage. For commercial users, they can log into https://www.microsoft365.com/. When it comes to work, it will depend. For example, many DoD users would sign into https://portal.apps.mil . Once logged in, various Office apps will be listed on the left-hand side of the page. If the Forms button is not displayed, an apps, or all apps, button will also be available. Clicking on it will list all the Office apps including Forms.

#### **PowerPoint Mouse Drag Shortcuts**

PowerPoint provides an easy way to move objects along a single axis. Most users will click and drag to move an object on a slide around. If you hold shift while dragging (Shift+Drag) an object, the object is easier to move only vertically or horizontally. Another option is to duplicate objects, Ctrl +Drag will create a duplicate of the selected object. Similarly, dragging an object with the right-click will give an option to move or copy the selected object to the new location when you release the right-click.

#### Adobe Keyboard Shortcuts

Press Ctrl++ to zoom in

Press Ctrl+- to zoom out

Press Ctrl+0 to zoom to 100%

Press Ctrl+Shift++ to rotate the page clockwise 90 degrees

Press Ctrl+Shift+- to rotate the page counterclockwise 90 degrees

Pressing Ctrl+F will open the text search box that allows you to search the pdf for specific text. This function is what most users are familiar with.

Pressing Ctrl+Shift+F will open the Advanced Find window. This search function will allow you to perform searches with specific criteria (e.g. whole words only, case-sensitive, etc.) There is also a "Look In" section that allows you to search the current document or search all pdfs in a specified folder. This is very useful if you need to look through several documents at a time.
